Legal Notice

The Athens-Hocking Solid Waste District, the Athens County Board of County Commissioners and the Hocking County Board of Commissioners will be holding three (3) public hearings with the intent to pass a continuing resolution to charge a Parcel Fee on all improved parcels in Athens County and Hocking County to provide revenue to maintain the Athens-Hocking Recycling Center and the Sutton Road Recycling Center and to pay to implement the Solid Waste District Management Plan to provide access and programs for proper solid waste disposal, recycling and diverting hard to recycle materials, recycling days and proper disposal of household hazardous waste. There will be three (3) public hearings. The first hearing will be conducted on: June 25, 2024 at 6:00 pm at the Athens Community Center, 701 East State Street, Athens. A second hearing will be conducted on July 2, 2024 at 6:00pm, the Nelsonville Public Library, 95 W. Washington, Nelsonville. A third hearing will be conducted on Thursday, July 11, 2024 at 6pm at the Hocking County Fairgrounds, Youth Building, Logan.
